



Terms and Conditions – "Dream like a Champion" Drawing Contest

Prizes and Rules

ARTICLE 1 - ORGANIZER

This drawing contest (hereinafter: "the Contest") is organized by Team Visma | Lease a Bike, located at Het Zuiderkruis 23, 5215 MV 's-Hertogenbosch, the Netherlands (hereinafter: "the Organizer").

ARTICLE 2 - DURATION

The Contest runs from 02-04-2026 to and including 13-04-2026. Submissions received after the closing date will not be considered.

ARTICLE 3 - PARTICIPATION

3.1 Participation in the Contest is free and open to children worldwide.

3.2 Children under the age of 16 must have permission from a parent or legal guardian to participate. Parental or guardian consent is also required for the collection of necessary personal data.

3.3 By participating, the parent or legal guardian agrees to these terms and conditions and the Organizer's privacy policy.



3.4 Only one submission per child will be accepted. In case of multiple submissions, only one drawing will be included in the judging process.

3.5 Submissions are only possible via the designated form on the Organizer's website. Submissions through other channels will not be processed.

ARTICLE 4 - THE DRAWING

4.1 Participants must create a drawing of their cycling dream using the template provided on the Organizer's website.

4.2 The drawing must be an original work by the participating child. Traced, copied, or otherwise non-original drawings will be disqualified.

4.3 The drawing must not contain offensive, discriminatory, or otherwise inappropriate imagery.

ARTICLE 5 - JUDGING AND RESULTS

5.1 The winning entries will be selected by a jury appointed by the Organizer. The selection of the winner(s) will be made impartially.

5.2 The results will be announced in mid-May. Winners will be contacted personally via the contact details provided with their submission.

5.3 The decision of the jury is final, and no correspondence will be entered into regarding the results.

ARTICLE 6 - PRIZES

6.1 Prizes include (among others):

A meet-and-greet with a rider from Team Visma | Lease a Bike

6.2 Prizes are non-transferable and cannot be exchanged for cash or other goods.

6.3 Prizes for individuals under 18 will only be awarded if prior consent from a parent or guardian has been obtained. The Organizer will verify this consent after the winners are announced.

ARTICLE 7 - COPYRIGHT AND USE OF THE DRAWING

7.1 Copyright of the submitted drawing remains with the creator (the child) or their parent/legal guardian.

7.2 By participating, the parent or legal guardian grants the Organizer a free, non-exclusive, worldwide, and unlimited license to use the submitted drawing for promotional and communication purposes. This includes (but is not limited to):

Publication on social media and the Organizer's website

Use in campaign materials (digital and physical)

Large-scale publication, including billboards, banners, print media, and other out-of-home advertising

Use in press releases and media productions

7.3 Where possible, the Organizer will credit the creator's name unless the parent or guardian has indicated otherwise.

7.4 No compensation will be provided for the use of the drawing.

7.5 The parent or legal guardian guarantees that the submitted drawing is an original work by the child and that its use by the Organizer does not infringe on any third-party rights.

ARTICLE 8 - PERSONAL DATA



8.1 For the purposes of the Contest, the Organizer processes personal data of participants and their parents/legal guardians. The Organizer's privacy policy specifies which data is collected, how long it is stored, and for what purpose.

8.2 Parents or legal guardians may request the deletion of their child's personal data or submission at any time. The Organizer will assess such requests within one month and, where possible, delete all data.

8.3 Personal data will not be retained longer than necessary for the execution of the Contest.

ARTICLE 9 - LIABILITY

9.1 The Organizer is not liable for any damage, of any kind, arising from participation in the Contest.

9.2 No rights can be derived from any printing or typographical errors.

9.3 The Organizer reserves the right to modify, suspend, or terminate the Contest early without participants being entitled to any compensation.

ARTICLE 10 - FINAL PROVISIONS

10.1 These terms and conditions are governed by Dutch law.

10.2 The Dutch Code of Conduct for Promotional Games of Chance applies to this Contest.

10.3 In all cases not provided for in these terms and conditions, the Organizer's decision is final.



10.4 If one or more provisions of these terms and conditions are found to be invalid or unenforceable, this will not affect the validity of the remaining provisions.
